AMENDMENT

Condominium Units And Time Sharing

- 4. Each unit, together with the appurtenant undivided interest in the general common elements of each unit owner's building, shall together comprise one condominium unit, shall be inseparable, may be conveyed, leased, devised, encumbered only as a condominium unit, but as a parcel of real property. This right to convey, lease, devise, or encumber a condominium unit does not extend to or include the following:
 - (a) Any transfer, convoyance, or use of a condominium unit or interest therein involving a real estate tenancy relationship not recognized under the laws of the State of Montana.
 - (b) Any transfer or conveyance of ownership of a condominium unit or any interest therein in fee simple absolute or any other real estate tenancy where the principal determination of the interest transferred or acquired depends upon an increment of time.
 - (c) Any transfer, conveyance, or use of a condominium unit or interest therein which is commonly referred to or known as "time sharing".
