AND BROUGHT BACK TO NORMAL LEVELS, IT WILL BECOME A VERY COSTLY FIX

### **FIRELIGHT PARKING RULES**

- **♦ PARKING IN THE STREET IS NOT ALLOWED**
- ♦ ALL UNITS HAVE TWO PARKING SPACES, ONE INSIDE THE GARAGE AND ONE OUTSIDE THE GARAGE. ANY OVERFLOW PARKING IS FIRST COME FIRST SERVE AND MUST DISPLAY A PARKING PASS.
- ♦ Anyone with guests staying over 12 hours must obtain a guest pass from HPM.

### WE'RE GETTING A FACELIFT!


