## **New Parking Passes**

Each owner in good standing will be issued a new parking pass effective November 1st, 2012 . The following is Common Element's Rule 2012.1:

## **Firelight Parking Passes**

Effective November 2012 Each unit owner shall be issued two Firelight Parking passes valid for a two year time period. The parking passes will be mailed to each owner in September 2012 with the pre annual meeting packet. Each owner will be responsible for distributing the passes to any tenants or property management companies. The new passes need to be in the vehicles by November 1st 2012 and old passes will no longer be valid. The reissue process as described will take place every two years and the passes will be dated as such.

Replacement parking passes can be purchased from Hammond Property Management for \$50. The owner of the unit must contact Hammond Property Management at 406-995-7220 to request the replacement. You will need to provide the pass number that you are replacing. A new pass will be reissued and the pass number you replaced will no longer be valid.
